Dealer registration and set-up will begin at 8:00 am. Coffee & pastries will be served during set-up.

Lunch service will be available selling hot dogs/polish dogs, soft drinks, water, chips, & candy bars.

1. Every precaution will be taken to secure your merchandise. However, Cupertino Coin Club and St. Joseph of Cupertino Church will assume no responsibility in case of any loss or damage. Professional security will be in effect continuously from 8:00 am to 6:00 pm. Each dealer is responsible for his/her own insurance.

2. The bourse fee for the show is:

8' straight table.....	\$130.00* (2 straights for \$255.00 – same dealer)
16' corner group.....	\$250.00*

*After 12/31/18, straights are \$140.00/\$275.00 and corners are \$270.00

Each table or group includes front table(s), one backup table, table covers and electrical connections.

4. The full fee must accompany the Bourse Application to reserve your space. Cupertino Coin Club reserves the right to refuse any application. Applications will be processed in the order they are received. Tables are confirmed on a first-come, first-served basis with final table assignment based on your number of years of attendance at the show. Refunds will be made if the Bourse Chairman or Show Chairman is notified at least 10 days prior to the show date.

5. Bourse tables are to be occupied by the dealer and/or his/her assistant(s) as listed on the Bourse Application. No space may be sublet without the prior permission of the Bourse Chairman. Bourse badges are limited to two (2) per 8' table and three (3) per corner group, exclusive of spouses/children. **Please only list dealers who will be actively working behind your table.** Additional badges may be purchased at the \$20 "Early Bird/Visiting Dealer" rate. “Early Bird/Visiting Dealer” purchasers will be allowed on the bourse floor after 8:30 am.

6. Cupertino Coin Club reserves the right to refund bourse fees, or part thereof, and expel from the show any dealer who misrepresents his/her merchandise by counterfeits, whizzed, reprocesses or other means or who does not abide by the above rules.
