- There were ten board members and no guests present.
- Recording Secretary Lyle Okamoto arrived late and reported nothing new.

Medal Design Contest

It's time to break out your drawing pencils for the 2016 Medal Design Contest. The winning design will be featured on our 2016 medals. The following guidelines must be followed:

- The design must be on unlined paper in a circle of six to eight inches in diameter.
- The subject matter of your reverse design may be in the form of a single photo, postcard, or group of drawings in one design. Not all members of our club are artists, so the subject matter may consist of cutout pictures and the like.
- You may submit an explanation of your design.
- You may submit a maximum of two designs.
- The designer's name or initials may not appear on the design or design explanation. These will be added after the winning design is selected.
- If your entry is of a private, commercial, trademarked, or copyrighted subject matter, then you must obtain written permission from the rights holder. If permission is not granted, then the runner-up design will be used.
- The following information must be placed on the design: "44th Coin Show", "Napredak Hall", and "February 2016".
- All entries may be submitted at a regular club meeting or mailed to the club at: CCC Medal Design, P.O. Box 448, Cupertino, CA 95015-0448.
- All entries must be delivered to the President by 8:15 PM at our April 10, 2015 meeting or arrive at our club's P.O. Box by April 10, 2015. The entries will be voted upon by our membership at our April 10, 2015 regular meeting.
- In the event of IDENTICAL design submissions, the first design submitted will be entered in the design contest.
- The winning design becomes the property of Cupertino Coin Club and will not be returned. All other entries will be returned. The Cupertino Coin Club Board of Directors reserves the right to modify the winning design to meet the requirements of the minting process. Any modifications will be cleared with the designer.
- The winning designer shall receive one copper medal as the winner's prize.

CUPERTINO COIN CLUB
BY-LAWS

ARTICLE I. Name

Section 1. The name of this organization shall be ~~“The~~ “Cupertino Coin Club” and referred in the by-laws as the “Club.”

Section 2. The official seal or logo of the organization is the Conquistador, DeAnza.

ARTICLE II. Objectives

Section 1. The objectives and purposes of this organization are to extend, promote and project numismatic activity throughout the local area and to foster and encourage the study of numismatics in all its forms with emphasis on youth participation.

Section 2. Notwithstanding any statements of purpose or powers aforesaid, this Club shall not, except to an insubstantial degree engage in any activities or exercise any powers that are not in furtherance of its specific and primary purposes.

ARTICLE III. Membership

Section 1. The membership of this club shall consist of adult and youth members. Youth members shall be those under 18 years of age.

Section 2. Application for membership in the Club shall be made to the membership committee, and when accompanied by the required dues and accepted by the Board of Directors, the applicant shall be in full standing at the next following regular meeting of the Club. Anyone may apply for membership. At the discretion of the president, good will gestures may be extended to the applicant.

Section 3. All members shall be entitled to all privileges in the Club except only members in good standing shall have the right to vote, hold office, and receive official publications.

Section 4. The Board of Directors shall have summary powers by a vote of majority of its members, to members, to suspend or expel and terminate the membership of any member upon conviction of a felony crime or any conduct which disturbs the order, dignity, business, harmony, or impairs the good name, popularity, or prosperity of the Club. Said member and/or members shall be notified in writing of such pending action and shall have the right to appear before the Board at the time of such action. The proceedings of the Board shall be final and conclusive.

ARTICLE IV. Officers

Section 1. The elected officers of the Club shall be a president, a vice president, a junior president, a recording secretary, a corresponding secretary, a treasurer, a historian, and six directors. The Board of Directors shall consist of the above officers, the immediate past president, a curator, and the Coin Press editor. ~~The curator and the editor shall be appointed by the newly elected president with the approval of the Board.~~ The newly elected president with the approval of the Board shall appoint a curator and a Coin Press editor. All members of the Board of Directors shall have a vote.

Section 2. Officers shall be elected at the annual meeting by ballot, for terms of one year, to office until successors are elected and inducted.

Section 3. The president, vice-president, or junior president, having served two consecutive terms, shall not be eligible for reelection to the same office at the next election.

ARTICLE V. Dues

Section 1. The annual dues shall be ~~five dollars for adult members, and one dollar for youth members,~~ set by the board, and the current dues shall remain in effect until changed. Dues are payable in advance on or before April 1.

Section 2. Members in arrears three months in payment of dues are subject to removal from the mailing list and suspension. Any members so suspended for nonpayment of dues may be reinstated as a member in good standing by payment of dues for the current year. Seniority may be reestablished by paying all back dues within 90 days following re-application.

Section 3. Members having paid dues for fifteen (15) years shall receive a Life Membership and shall be subject to no further dues. Members may prepay dues up to their fifteenth year and shall be considered in full standing until they become Life Members. Proration shall be used to determine prepayment (15 [minus years in full standing] x current dues).

Section 4. Any member serving in the Armed Forces of the United States of America, upon written request, may retain membership without dues for a maximum of four (4) years. ~~Initial and extension of time must be granted by the Board of Directors.~~ The Board of Directors must grant initial and extension of time.

ARTICLE VI. Meetings

Section 1. Meetings shall be held each month, at the time and place designated by vote of the members, in regular meeting, unless such day falls on a holiday when it may be put over to another date by order of the president.

Section 2. The regular monthly meeting in March shall be considered the annual business meeting, at meeting, at which a resume of the year's activities shall be presented, and reports of officers and committees received, and the annual election of officers held.

Section 3. One-fifth of the members in good standing shall constitute a quorum for transacting the regular business of the Club.

Section 4. Meeting of the Board of Directors shall be held at such time and place as may be designated by the president or by action from time to time by the members of the Board. The quorum shall be a simple majority of the officers' and directors' offices that are filled at that time with each Board member having only one vote.

Section 5. Special or social meetings may be called by action of a quorum present at any regular meeting of the Club.

ARTICLE VII. Elections

- Section 1.** To be an eligible candidate for president, vice president or treasurer, that person shall be an adult member and have held any office on the Board of Directors of one or more terms in the last five (5) years.
- Section 2.** All officers shall be elected by ballot from a list of candidates supplied by the nominating committee and/or any nominations from the floor at the annual meeting.
- Section 3.** Only members in good standing shall be eligible to vote in the election of officers at the annual meeting.
- Section 4.** Good standing shall mean dues fully paid.

ARTICLE VIII. Duties of Officers

- Section 1.** The president shall preside at all meetings, shall decide all points of order, appoint all committees special or otherwise as may be necessary or ordered, and in case a vacancy should occur, the president shall have the power to appoint a successor to the unexpired term of such vacancy, subject to approval of the Board of Directors, and perform such other duties as prescribed from time to time by action of the members. The president is ex-officio on all committees.
- Section 2.** The vice president shall assume the duties of the president in the president's absence or inability to act, and in case of a vacancy, shall become president. The vice president shall at all times aid and assist the president in the discharge of the duties as may from time to time be assigned by action of the members or the president.
- Section 3.** The recording secretary shall keep a true and correct record of the proceedings of the club, and of the Board of Directors. In the event of the inability to attend a meeting, the recording secretary shall see that the books and records are made available to the meeting, and upon expiration of term of office shall turn over to the successor all books, records, and accessories of the office, taking a receipt therefor.
- Section 4.** The corresponding secretary shall attend to the correspondence of the club, including the sending of all announcements, by-laws, and membership card to new members, and keeping on file all important communications and copies of the replies thereto. In the event of inability to attend a meeting, the corresponding secretary shall see that the books and records are made available to the meeting and upon expiration of the term of office shall turn over to the successor all books, records, and accessories of the office, taking a receipt therefor.

- Section 5.** The treasurer shall receive all monies due the club and keep a true and accurate account of money received and paid out. The treasurer shall establish banking accounts in the name of the club with the treasurer's and the president's names on the authorization cards. (Only one signature is required to withdraw funds.) The treasurer shall keep the records in a ledger, which with the bankbooks shall be audited. All bills shall require a receipt. Bills may be paid in cash through a petty cash system. The annual report shall be read and a typewritten copy filed at the regular meeting following the annual meeting. The treasurer shall collect all dues, issue receipts therefore and pay all bills as approved by the Board of Directors. The treasurer shall report the condition of the treasury at each meeting of the club and shall at the expiration of the term of office turn over all funds, books and records of the office to the successor, taking a receipt therefor.
- Section 6.** The historian shall retain the non-current records of the club and will make these records available upon reasonable notice to members of the Board of Directors for meaningful research. The historian shall prepare and maintain a scrapbook of significant items pertaining to the club and its members, as well as a file of all club publications. At the end of the term of office, the historian shall turn over to the successor all records and property of the club, taking a receipt therefor.
- Section 7.** The curator shall retain all property of the club, which is of numismatic value except literature and those items purchased for distribution to the members as prizes. The curator shall from time to time prepare items so retained for display. The curator shall have the authority to purchase additional items for the club at fair market value or less within the limits and budget set forth by the Board of Directors. The curator shall maintain an up-to-date listing of all items in triplicate, one copy to be retained by the curator, one by the president, and one by the recording secretary. At the end of the term of office, the curator shall turn over all Club property and records to the successor, taking a receipt therefor.
- Section 8.** The junior president shall represent the youth members at all meetings and shall assume the duties of the program chairman at the annual youth night.
- Section 9.** The editor shall have full charge of editing, ~~and publishing~~ and distributing the Coin Press ~~and shall mail or cause to be mailed the Coin Press~~ so that copies arrive to members prior to each monthly membership meeting. The editor shall maintain a current year's set of the Coin Press, to be filed yearly (in March) in the Club's files.
- Section 10.** The Board of Directors upon call of the president shall take up for consideration and recommendation, all matters or questions for the betterment or improvement of the club, and shall handle all complaints that may arise from any source. The Board shall pass on, and approve for payment all bills presented to the club, and all applications for membership. Note: Board Minutes will be available for review at the monthly meetings or reported in the Coin Press.

ARTICLE IX. Committees

- Section 1. At least two meetings before the annual meeting, the president shall appoint a nominating committee of three members to present names of candidates for each office one month prior to the annual meeting. The consent of each candidate must be obtained before presenting the name for the respective office to be filled.
- Section 2. At the annual meeting, the president shall appoint an auditing committee of two members to audit the books of the treasurer. The committee shall report back its findings to the membership.
- Section 3. All official correspondence by officers and chairmen shall be in triplicate, one copy going to the president and one copy going to the corresponding secretary.
- Section 4. Any special chairman's bank account shall be in the name of the club and have the chairman's and president's names on the authorization card.

ARTICLE X. Amendments

- Section 1. These by-laws may be amended at any regular meeting of the club by two-thirds affirmative vote of those present, eligible to vote and voting, provided written notice of such intention shall have been given to the membership before two consecutive regular meetings of the club. All amendments so adopted shall become effective immediately after enactment.

ARTICLE XI. Parliamentary

- Section 1. *Robert's Rules of Order [Newly Revised](#)* shall be the official guide of the club in parliamentary procedure.

ARTICLE XII. Dissolution

- Section 1. In the event of a dissolution, all funds and material ([curator collections, club history and numismatic sets](#)) belonging to the Cupertino Coin Club ~~will be transferred and become the property of the San Jose Coin Club~~ [shall be donated to the American Numismatic Association for youth programs.](#)

ARTICLE XIII. Effective Date

- Section 1. These by-laws supersede the original by-laws and any amendments thereto.
